



Terms and Conditions:

1. Only payments made in Hong Kong Dollars via American Express Interest-Free Installment Program (“Installment Program”) are considered eligible transactions. [Installment Program Terms and Conditions](#) apply.
2. Prior to payment, Cardmembers must inform the [Installment Program merchant](#) (“Participating Merchants”) they wish to make payment via the Installment Program. The Installment Program may not be applicable to some products or services, please confirm directly with the Participating Merchants.
3. The registration period commences on 2025/10/22 and ends on 2025/12/22, both dates inclusive (“Promotion Period”). Participation is limited to the first 50,000 Eligible Cards that are successfully registered.
4. Cardmembers must successfully register an Eligible Card during the Promotion Period, then spend a net amount of HK\$2,000 or more, in one transaction via Installment Program (“Spending Requirement”) in-person only at Participating Merchants in Hong Kong with the Registered Card during Promotion Period (“Eligible Transaction”) to receive HK\$200 back in statement credit (“Registered Card Offer”).
5. The Registered Card Offer is open to individuals who hold Basic and/or Supplementary American Express® Cards issued by American Express International, Inc. (“American Express”) in Hong Kong (“Eligible Cards”), excluding American Express® Corporate Cards and Cards bearing the American Express name, brand or logo issued by partners of American Express.
