



Terms and Conditions :

1. The registration period commences on March 1, 2024 and ends on March 31, 2024, both dates inclusive ("Promotion Period").
2. Cardmembers must successfully register an Eligible Card during the Promotion Period ("Registered Card"), then spend a net amount of HK\$500 or more, in one transaction ("Spending Requirement") in-person at [participating City Super Group | City Super 集團](#) ("Participating Merchant") locations in Hong Kong ("Participating Locations") with the Registered Card during Promotion Period ("Eligible Transaction") to receive HK\$50 back in statement credit ("Registered Card Offer").

條款及細則：

1. 此登記卡優惠適用於2024年3月1日至2024年3月31日，包括首尾兩日（「推廣期」）。
2. 卡會員須於推廣期內成功登記合資格美國運通卡（「登記卡」），並在推廣期內憑已登記卡親身於 [香港City Super Group | City Super 集團參與門市](#)（「參與商戶」）單一簽賬淨額滿HK\$500或以上（「簽賬要求」）（「合資格交易」），可獲HK\$50 簽賬回贈（「登記卡優惠」）。
